The Archgola Warranty

This document details the warranties which accompany the Terms and Conditions of Trade ("Terms") in relation to the supply of goods and services from

Archgola _____ Limited

company number _____ ("us", "our", "we"). The warranties specified in this document are made by us as a licensee of Archgola and not Archgola Limited itself. This warranty does not limit your rights at law. Please read the following carefully.

Defined terms and expressions in these Warranty Details have the same meaning given to those in the Terms unless the context indicates otherwise.

1. Warranty Limitations and Exclusions

Our Warranty obligations do not apply to the extent caused by:

- Reasonable wear and tear, or superficial defects, dents or marks that do not impact the performance or integrity of our Products;
 - Normal corrosion;
 - use of unapproved parts or unproved alterations to components to the extent prohibited by our Product Care Guidelines;
 - vandalism, misuse or a Force Majeure Event;
 - accidents or damage caused by you;
 - dirt, dust, bird excrement, animals, insects, foliage or algae growth;
 - pre-existing conditions of your home, including the structure and ground conditions;
 - someone other than us installing, altering, removing, reinstalling or repairing any part of your Product;
 - Where the Archgola is outside of either marine, industrial or geothermal zone, a failure to clean it every six (6) months.
 - Where the Archgola is in a marine zone (i.e. within 500m of the sea or salt water lake), a failure to clean residual salt at least every two (2) months.
 - Where the Archgola is in an industrial zone, a failure to clean residual chemicals from any industrial pollution by washing at least every three (3) months.
 - Where the Archgola is in a geothermal area, a failure to clean the frame every three (3) three months.
 - The powder coated surfaces must not be exposed to any caustic or spirit based cleaners under any circumstances.
- Nothing in this warranty limits or voids any supplier or manufacturer's warranty which provides you with additional

and/or greater warranty rights set out in this Warranty information. We will assign to you any Manufacturer Warranties relating to the Products and/or Services we supply to you which exceed our warranty periods set forth in these "Warranty Details".

2. Installation Warranty

All Products installed by us carry a five (5) year workmanship warranty from the date of completion of construction.

3. The Ezi Guide Blind and Gearbox Warranty

Providing the ongoing Archgola Product Care Guidelines are strictly adhered to, both the curtain and the gearbox carry a two (2) year warranty.

4. Aluminium Channel and Remaining Components

Providing the ongoing Archgola Product Care Guidelines are strictly adhered to, all remaining components carry a five (5) year warranty. (This includes all aluminium components, locking devices brackets and inserts).

5. Archgola Product Care Guidelines

To comply with the Warranty requirements and to extend the effective life of the Ezi Guide Blind, the powder coated finish and the functionality of the moving components, a very simple maintenance programme should be implemented.

The Frame and the Blind

Maintenance should be carried out every six (6) months - apart from Marine, Industrial and geothermal areas where cleaning should be every three (3) months.

Carefully remove any loose deposits with a wet sponge. Use a soft brush (nonabrasive) and a mild household detergent solution to remove dust, salt and other deposits. Rinse off with clean fresh water.

Warranties will become void if damage is caused by leaving blinds wound up while wet or left down during periods of very high winds.

DO NOT leave blinds wound up for extended periods of time if they are wet or damp and blinds should be wound up during periods of very high winds.

DO NOT leave blind down during periods of very high winds. Moisture can be detrimental to both the fabric integrity and the long-term effectiveness of the fabric welds neutral detergents and minimise contact with the surface.
